SIMPLE STEPS TO DONATE AND REDUCE YOUR TAXES

1. Donate to the Care Fund, an Arizona qualifying charitable organization by Dec. 31st.
2. Claim an annual tax credit reducing dollar-for-dollar your state income tax.
3. Individuals or head of household filers can claim a tax credit of UP TO \$200.
4. Couples who file jointly can reduce their state taxes UP TO \$400.

HOW DOES IT WORK?

1. Prepare your Arizona state tax return .
2. Claim the Care Fund donation tax credit when you file your return.

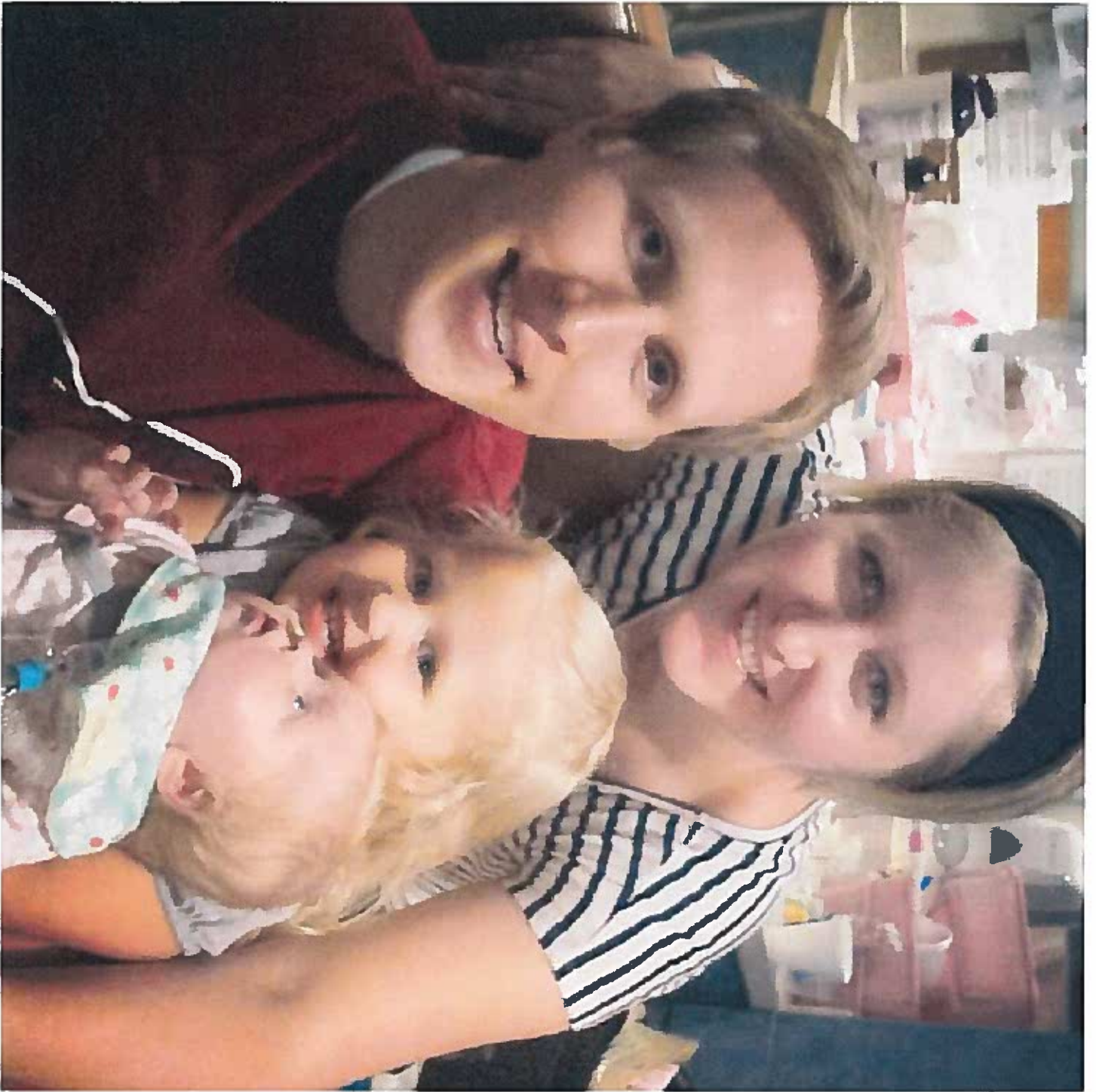

HISTORY

A major health crisis is never planned... The Care Fund was created through a unique collaboration of business goodwill and community vision. It is a statewide effort to help support Arizona families who experience financial loss during an extended illness or injury to their child. A family mortgage or rent is the largest and most significant financial living expense. Parents must focus on the care of their child. Many do not have the resources to take time off, and may face job loss as well as exorbitant medical bills and medications. The Care Fund grants mortgage or rent payments to qualified families who need care and support. Keeping families in their homes ensures healthier families, neighborhoods and communities.

PARTNERING WITH THE CARE FUND

Today, the Care Fund has granted over 100 families throughout the state of Arizona, representing over 25 cities. The average monthly grant is \$900, and the average number of months granted to a family in need is approximately 3-months of mortgage or rent. Families are referred to the Care Fund through different channels: hospital case workers, personal referrals, home health organizations, social media or word of mouth. All families must go through a granting qualification process to determine need.

SUPPORT

Support the community in which you live, work and play. The Care Fund is a granting and fundraising 501(c)(3) non-profit, supporting families throughout the state of Arizona. DONATIONS

Donations are made through private, public contributions and matching grants to assist Arizona families.

- **Pledged Giving** – make a pledge goal or ongoing pledge commitment
- **Transactional Giving** – make a donation with each sales transaction
- **Individual Giving** - utilize payroll deductions for sustained giving
- **Corporate Matching** – companies may match employee giving. Care Fund is United Way approved.
